The College's Privacy Notice applies to information it collects from individuals including:

- People who have enrolled on a course
- People who apply for funding or support from the College
- Visitors to the college or Morley Radio websites
- People who request course guides, course specifications, send an enquiry or apply online
- Those who register to attend Morley College London's programme of events
- People who sign up to promotional competitions run by the College
- Individuals who register to become a member of Friends of Morley
- Users of the College Moodle VLE system

About our information collection

What information do we collect and how do we use it?

Where the information collected by the College includes personally identifiable information, the College will make this clear and will explain how it intends to use this information. Where relevant, an option will be provided to allow users to unsubscribe to on-going communications.

When someone visits the College website we collect standard internet log information and details of visitor behaviour patterns. This is to help us analyse those patterns, track visitor numbers and improve the user experience of website visitors. We collect this information in a way which does not personally identify those using our website. We will not associate any data gathered from this site with any personally identifying information from any source.

Sharing personal details with third parties

The College will keep personal details confidential and only share information with third parties where it is legally or contractually obligated to do so, such as to meet the requirements of the Education & Skills Funding Agency, the Student Loans Company and partner universities and colleges with whom we have collaborative agreements.

CECOS College is committed to protecting your privacy. Data supplied will be used only for the purpose stated at the point of collection and will be kept in accordance with the terms of our Privacy Notice.



Your rights

The General Data Protection Regulation provides you with certain statutory rights, including:

- The right to access your personal data
- The right to have personal data rectified
- The right to request the deletion or removal of personal data
- The right to restrict processing of personal data
- The right to obtain and reuse personal data for your own purposes across different services (portability)
- The right to object to processing in certain circumstances
- The right not to be subject to a decision when it is based on automatic processing and produces a legal or similarly significant effect on the individual
